Our first Meeting of 2024

The first meeting of the year of AOPF took place on the 18th January with a full Agenda covering the New Hospital Consultation, Iron Age Museum closure, Hampshire County Council cuts but more of that later on. After refreshments we were glad to welcome our special guest speaker Anne Godding from **The** Countess of Brecknock Hospice Trust. Anne was able to tell us all about the new facilities and the work that went into the fundraising and getting the new build completed. We heard about the day-care room, the support given to patients living at home and how they did everything they could to cater for all their inpatients' wishes and needs in the hospice which could be anything from a party to having a cuddle with their pets. If you were one of the audience I am sure you agree Anne's talk was enlightening and inspiring and we thank her for taking the time to come and speak to us.

Now on to other news

New Hospital Consultation.

Have you heard? The NHS in Hampshire is consulting on proposals to build a new hospital,

invest in Winchester hospital and make changes to acute hospital services in Basingstoke and Winchester. It is important that we have a say in how services could be delivered in the future.

The consultation finishes on 17th March 2024 and live and virtual meetings are still being held so please take part if you can.

We have also been invited to join Romsey STOIC to attend their listening meeting on 12th March 2024 at Crossfield Hall in Romsey. There will be a Pop-Up display in the Chantry Centre later in the month and details of the consultation will be in GP Surgeries and Community Centres.

The Forum had hoped to arrange a special meeting with a Speaker and Questions and Answers and give our views on the proposals in the early part of February. Unfortunately the dates we offered have not been taken up at this time.

Jenny Kay, our Chairman, together with Brian Kay attended one of the Virtual Consultation meetings and here is their report.

We joined the virtual meeting half an hour late owing to a prior engagement but we felt we got the main gist of the meeting.
We were given an outline of the three proposals that are in place which can be found via the following:

After this we were split into groups headed by
one of the speakers present at the meeting. We
all had an opportunity to put our views; I was
able to quote from the comments that had
been voiced from our members at our AOPF
meeting the day before.

I brought up the question about the lack of a heliport in the new plans that Haydn Watkins, our Vice Chair, had brought up and although it was agreed it would help to have one and may still be considered the Dr leading our group did comment that the money could be spent in other areas rather than solely on the heliport.

I brought up the point Mollie Antrobus, our Events Organiser had mentioned, whether the new plans would make a difference to the AWMH outpatient facilities and was assured that we will still get the full amenities including outpatients.

The plans are for more Rehab facilities in local areas. To increase specialist nurse run care in the community to enable patients to return home sooner and relieve hospital places and to receive more treatment such as cancer care in our own homes.

We did get the impression that our voices are being heard and that they hope people will come along to the meetings that are arranged to inform us more about the three alternatives proposed.

Hampshire County Council Budget Cuts

One of the consequences of the HCC budget cuts could be the closure of the Iron Age Museum. Hampshire Cultural Trust (HCT), which has been warned of a £600,000 grant cut, said it may close five venues.

Launching a consultation on planned service cuts on Monday, Hampshire County Council leader Rob Humby said "tough decisions" were needed to find the necessary savings. The authority said household waste sites at Alresford, Bishop's Waltham, Fair Oak, Hartley Wintney and Hayling Island were most at risk of closure.

It said it planned to withdraw all funding for homelessness support services, which could result in the closure of emergency hostels.

Street lights in some areas would be switched off from midnight until 05:00 GMT, instead of the current three-hour period of darkness.

The council said it would also end funding for community transport schemes, bus services, some school crossing patrols and three adult social care grant schemes for organisations.

It said 4,000 people would also be asked to pay more towards their home care.

How to have your say.

The consultation runs from midday on 8 January to 11:59pm on 31 March 2024. There are 13 service change proposals in total and views can be provided on some or all of them, as preferred.

Where possible, residents are encouraged to consider completing the consultation Response Form online as this will help save money, both in postage and in staff time in manually entering responses to the consultation. Maybe a friend or member of your family can assist with this?

Report Concerns

If you are concerned that you or another adult is being neglected, harmed, or abused in any way, please do not ignore it. Any suspicion of abuse or neglect should be reported to Hampshire County Council Adults' Health and Care.

- If you or someone else is in imminent danger, phone the police on **999**, or call them on **101** if it is less urgent.

- Your concerns will be looked into fully and fairly.
- You will be involved in decision making and trained staff will work with you to stop the abuse and agree with you steps to protect you from further harm.
- You will get advice about the help and support available.
